

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE
TOWNSHIP OF MOUNT OLIVE ESTABLISHING A TEMPORARY
BUDGET FOR 2015 FOR THE CURRENT, WATER, SEWER AND
RECREATION UTILITY AS WELL AS THE SANITATION
DISTRICT**

WHEREAS, NJSA 40A:4-19 provides that where any contract, commitment or payments are to be made prior to the final adoption of the 2015 budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided; and

WHEREAS, the date of this resolution is within the first thirty days of January 2015; and

WHEREAS, the total appropriations in the 2014 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund and public assistance in said 2014 budget is the sum of \$22,933,059 for current fund, \$1,400,959 for water utility, \$2,816,861 for sewer utility, \$816,168 for recreation utility and \$2,741,756 sanitation district, and

WHEREAS, 26.25% of the total appropriations in the 2014 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund and public assistance in said 2014 budget is the sum of \$6,019,927.98 for current, \$367,751.74 for water utility, \$739,426.01 for sewer utility, \$214,244.10 for recreation utility and \$719,710.95 for the sanitation district;

NOW, THEREFORE BE IT RESOLVED that the following appropriations be approved by the Township Council of the Township of Mount Olive retroactive to January 1, 2015.
