

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE
AUTHORIZING THE AWARD OF CONTRACTS FOR SNOWPLOWING SERVICES TO
ANDY MATT INC., MD SAVAGE LLC AND SALMON BROS., INC.**

WHEREAS, the Township advertised and received bids for snowplowing services from the following vendors,

Andy Matt Inc.

WHEREAS, the Township Council is satisfied with the proposals submitted by Andy Matt Inc., MD Savage LLC and Salmon Bros., Inc., the lowest responsible bidders for their respective snowplowing routes, as being the proposals which satisfy the best interests of the Township and being in conformance with the requirements promulgated pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, the Township wishes to proceed with this necessary service and for that purpose accepts the proposals submitted by Andy Matt Inc., MD Savage LLC and Salmon Bros., Inc.;

NOW THEREFORE BE IT RESOLVED by the Township of Mount Olive, in the County of Morris and State of New Jersey, as follows:

1. It does hereby authorize the issuance of contracts to Andy Matt Inc., 11 Scrub Oaks Road, Mine Hill, New Jersey 07803; MD Savage LLC, 4 Woods End Road, Newton, New Jersey 07860 and Salmon Bros., Inc., 5 Furnace Street, Stanhope, New Jersey 07874 for snowplowing services, which contracts shall specify the scope of services as set forth in Andy Matt Inc., MD Savage LLC and Salmon Bros., Inc.'s proposals, at total costs and prices not to exceed those set forth in the proposals.
2. The Mayor is specifically authorized to execute the aforementioned contracts.

This resolution will take effect immediately upon its passage.
