

Please let this letter serve to inform you and your staff that effective December 16, 2013 *Howard TV (SVOD)* on channel 513, offered as an a la carte channel for \$12.95 per month, will no longer be available to Residential customers in all New Jersey systems. Howard TV has ceased operations and is no longer available.

Customers will be notified of these changes through on-air banners and bill messages.
