

Dear Mayor:

This is to update you on the cancellation of the 97th Annual League

Conference. Please share this letter with your Administrator and Finance Officer.

As part of the claims resolution process pursuant to the League's event cancellation insurance policy, we are commissioning a survey to both the pre-registered conference delegates and the pre-registered exhibitors to gather data needed by our insurance provider. That survey work will be performed in the next two or three weeks using contact information provided by the League to professional pollsters.
