

The Office of Planning Advocacy has scheduled six public hearing for the latest incarnation of the State Plan. The “draft State Strategic Plan” was unveiled by the Christie administration in the fall as an update to the State Development and Redevelopment Plan. The draft plan intends

to develop a strategic vision for where and how New Jersey should grow.
