**AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, PROVIDING FOR THE ESTABLISHMENT OF NO PARKING ZONES ON CERTAIN SECTIONS OF GLENDALE ROAD AND HILLERY DRIVE [TO BE INCORPORATED INTO CHAPTER 245 OF THE MOUNT OLIVE TOWNSHIP CODE]**

**WHEREAS**, the Mount Olive Township Police Department recommends a “No Parking Zone” during times when sporting events are scheduled at Dan Jordan Field which requires overflow parking on municipal streets; and

**WHEREAS**, the Mount Olive Township Police, Traffic Bureau has certified to the Township Council that they have investigated the traffic complaints and circumstances on the roadways in question, that it appears to the police department that elimination of parking on one side of the street is in the best interest of the public safety and the expedition of traffic; and

**WHEREAS**, the sections of the roadways in question are wholly contained in the Township of Mount Olive; and

**WHEREAS**, N.J.S.A. 39:4-197 authorizes the Township to pass, without the approval of the New Jersey Commissioner of Transportation, an ordinance regulating the parking of vehicles on streets and portions thereof that are under the jurisdiction of the Township;

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Mount Olive, in the County of Morris, State of New Jersey as follows:

Chapter 245 of the Mount Olive Township Code entitled, “Vehicles and Traffic” is hereby amended to incorporate the following:

**SECTION 1.** Commencing (20) days upon final passage, approval and publication as required by law, Glendale Road, from Hillery Drive to Tulane Road, is restricted to parking on one side of the street on Friday, Saturday, and Sunday between the hours of 8:00 AM and 8:00

PM daily. Parking will be permitted on the eastern side of the street (side of Dan Jordan Field) and parking is prohibited on the western side of the street (opposite of Dan Jordan Field).


**SECTION 2.** Commencing (20) days upon final passage, approval and publication as required by law, Hillery Drive, from the intersection of Route 206 to the intersection of Devonshire Terrace, is restricted to parking on one side of the street on Friday, Saturday, and Sunday between the hours of 8:00 AM and 8:00 PM daily. Parking will be permitted on the north side of the street and parking will be prohibited on the south side of the street.

**SECTION 3.** All ordinances of the Township of Mount Olive which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4.** If any section, subsection, clause or phrase of this ordinance is for any reason held to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portion of this ordinance.

**SECTION 5.** This ordinance may be renumbered for purposes of codification.
