**AN ORDINANCE OF THE TOWNSHIP OF MOUNT OLIVE, COUNTY OF MORRIS,
AND STATE OF NEW JERSEY SUPPLEMENTING CERTAIN PORTIONS OF
CHAPTER 400, LAND USE, SECTION 400-10, BUILDING CONSTRUCTION,
SUBSECTION 400-10(B), FEES, OF THE REVISED GENERAL ORDINANCES WITH
REGARDS TO PLUMBING, ELECTRICAL AND FIRE SUBCODE FEES**

BE IT ORDAINED, by the Council of the Township of Mount Olive in the County of Morris and the State of New Jersey as follows:

SECTION 1. Chapter 400, Land Use, Section 400-10, Building Construction, Subsection 400-10(B)(2)(A)(2), Plumbing subcode fees, of the aforesaid Revised General Ordinances is hereby supplemented with the addition of the following subcode fee:

§ 400-10. Building Construction.

B. Fees.

[2] The plumbing subcode fees shall be:

[v] For all non-listed items the fee shall be \$30.00 per item.

SECTION 2. Chapter 400, Land Use, Section 400-10, Building Construction, Subsection 400-10(B)(2)(A)(3), Electrical subcode fees, of the aforesaid Revised General Ordinances is hereby supplemented with the addition of the following subcode fee:

§ 400-10. Building Construction.

B. Fees.

[3] The electrical subcode fees shall be:

(k) For all non-listed items the fee shall be \$25.00 per item provided that the minimum fee shall be \$46.00

SECTION 3. Chapter 400, Land Use, Section 400-10, Building Construction, Subsection 400-10(B)(2)(A)(4), Fire subcode fees, of the aforesaid Revised General Ordinances is hereby supplemented with the addition of the following subcode fee:

§ 400-10. Building Construction.

B. Fees.

[4] The fire subcode fees shall be:

(k) For all non-listed items the fee shall be \$35.00 per item.


SECTION 4. All ordinances of the Township of Mount Olive, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

SECTION 5. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 6. This Ordinance may be renumbered for purposes of codification.

SECTION 7. This Ordinance shall take effect immediately upon final passage, approval, and publication as required by law.
