BOND ORDINANCE AMENDING SECTION 3(h) OF BOND ORDINANCE #13-2012 (AS AMENDED BY BOND ORDINANCES #25-2012, #33-2012 AND #6-2013) OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY IN ORDER TO PROVIDE FOR TURKEY BROOK TOT LOT IMPROVEMENTS.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section One. Section 3(h) of Bond Ordinance #13-2012 (as amended by Bond Ordinances #25-2012, #33-2012 and #6-2013) of the Township of Mount Olive, in the County of Morris, New Jersey (the "Township"), finally adopted April 24, 2012 (as amended July 24, 2012, October 16, 2012 and March 19, 2013) is hereby further amended to provide for "Turkey Brook tot lot improvements" in the third paragraph so that it will read in its entirety as follows:


"Improvements to rims and backboards for the Turkey Brook basketball courts and the fields, the turf soccer field and football field lighting at Turkey Brook Park, the 3 Phase Power at Turkey Brook Park Project, Turkey Brook tot lot improvements, the acquisition of a portable emergency generator for the Senior Building and the acquisition of a sign for the Municipal Building, including all related costs and expenditures incidental thereto and further including all work and materials necessary therefor and incidental thereto."

Section Two. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with


the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section Three. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
