

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE AUTHORIZING A CHANGE ORDER TO THE CONTRACT FOR THE REBURBISHMENT OF BUDD LAKE FIRE DEPARTMENT UNIT 53 PREVIOUSLY AWARDED TO KOVATCH MOBILE EQUIPMENT CORP.**

**WHEREAS**, the Township previously awarded a contract to Kovatch Mobile Equipment Corp. in the amount of \$233,000 for Refurbishment of Budd Lake Fire Unit 53 and

**WHEREAS**, in connection with Kovatch Mobile Equipment Corp. work pursuant to the aforementioned contract it was determined by Kovatch Mobile Equipment Corp. that the following items were not covered in specifications and require for successful completion of bid:

1. Rewire four (4) push button switches with four (4) protected on-off-on momentary switches.
2. Interlock Jacobs Brake with park brake.
3. Rebuild five (5) additional valves; left side Aux suction. Discharge #4 trash line on officer side, LDH discharge and pre-connect #4.
4. Install roll up door protector in rear roll up door.

**WHEREAS**, Kovatch Mobile Equipment Corp. has proposed conduct the aforementioned work on Unit 53; and

**WHEREAS**, Kovatch Mobile Equipment Corp. has proposed to perform this work for \$3,805.00; and

**WHEREAS**, pursuant to Memorandum, dated April 16, 2014, the Township's Business Administrator has brought the need for a change order to perform this work to the Township Council and finds the work necessary and has recommended passage of the change order in the amount of \$3,805.00 and

**WHEREAS**, in accordance with N.J.A.C. 5:30-11.3, the change order has not caused the originally awarded contract price to be exceeded by more than 20 percent; and

**WHEREAS**, in accordance with N.J.A.C.5:30-11.8, this change order constitutes a minor modification to resolve a minor problem.

**NOW THEREFORE BE IT RESOLVED** by the township of Mount Olive, in the County of Morris and State of New Jersey, that it authorizes a written amendment to the contract with Mobile Equipment Corp. at a cost not to exceed \$3,805.00 as set forth in the change order proposal submitted by Mobile Equipment Corp.
