

REVISION TO THE NORTHEAST WATER QUALITY MANAGEMENT PLAN

TAKE NOTICE that on _____, pursuant to the provisions of the Water Quality Planning Act, N.J.S.A.58:11A-1 et seq, and the Statewide Water Quality Management Planning rules, N.J.A.C. 7:15-3.5, a revision to the Northeast Water Quality Management (WQM) Plan was adopted by the Department. This revision will correct the Northeast WQM Plan to include four existing small individual sewer service areas located in Morris County. The four treatment plants are Flanders Valley Business (NJG0147648) in Mount Olive Township, Green Valley Shopping Center (NJG0128830) in Jefferson Township, Greystone Park Psychiatric Hospital (NJ0026689) in Parsippany Township, and New Orleans Steak House (NJG0129551) in Jefferson Township.
