

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF  
MOUNT OLIVE RELATIVE TO MOUNT OLIVE WEEK CARNIVAL  
(7/10/13-7/14/13) AND FIREWORKS SCHEDULED FOR (7/13/13)  
AND RAIN DATE (7/14/13)**

**WHEREAS**, the Township's Recreation Department is planning what is to be known as the Mount Olive Week Carnival which will be conducted between July 10th and July 14<sup>th</sup> with fireworks scheduled for July 13<sup>th</sup> with a rain date of July 14<sup>th</sup> for 9:15pm; and

**WHEREAS**, it is necessary to make some significant restrictions as to parking during these events and to waive certain other restrictions so that the programs may go forward.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Mount Olive as follows:

1. The hours of operation of Turkey Brook Park shall be extended from sunset to 11:45 p.m. from Wednesday, July 10<sup>th</sup> through Sunday, July 14<sup>th</sup>.
2. The Noise Ordinance which is applicable under normal circumstances shall be waived from a 10 p.m. deadline to an 11:45 p.m. deadline on Wednesday, July 10<sup>th</sup> through Sunday, July 14<sup>th</sup> as the carnival continues until each evening until 11 p.m. Noise may continue until 2 am on July 14<sup>th</sup> as the Carnival breaks down.
3. Certain parking restrictions are necessary and appropriate under the circumstances and those restrictions are as follows:
  - a. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department on local streets for the duration of this event, i.e. from 5 pm to 11 p.m. on July 10 through the 12 , and from noon to 11 p.m. on July 13 and July 14.
  - b. There shall be no parking on Sunset Drive from 5 p.m. to 11 p.m. on July 10 through the 12 and from noon to 11 p.m. on July 13 and July 14.
  - c. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department in Gold Mine Estates, from 5 p.m. to 11 p.m. on from July 10 through the 12 and from noon to 11 p.m. on July 13 and July 14.
  - d. Wynnewood Avenue between Clinton Avenue and Flanders Road, and, Chelsea Avenue between Clinton Avenue and Flanders Road shall be closed to vehicular traffic on July 13 or on the rain date of July 14, between 4 p.m. and 11:00 p.m. either day.

- e. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department, on Pershing Avenue, Washington Street, Delbar Drive, Summit Avenue, Stanley Place, and Carson Road from 5 p.m. to 11 p.m. on from July 10 through the 12 and from noon to 11 p.m. on July 13 and July 14.
4. The carnival company shall be allowed to park their RV's within Turkey Brook Park for the purpose of providing overnight sleeping accommodations for the Carnival staff;
5. A temporary waiver to Section 176-8 of the Township Code which prohibits the posting, exhibiting and displaying of signs on Township property.
