

RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE RELATIVE TO MOUNT OLIVE WEEK CARNIVAL (7/9/14-7/13/14) AND FIREWORKS SCHEDULED FOR (7/12/14) AND RAIN DATE (7/13/14)

WHEREAS, the Township's Recreation Department is planning what is to be known as the Mount Olive Week Carnival which will be conducted between July 9th and July 13th with fireworks scheduled for July 12th with a rain date of July 13th for 9:15pm; and

WHEREAS, it is necessary to make some significant restrictions as to parking during these events and to waive certain other restrictions so that the programs may go forward.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Mount Olive as follows:

1. The hours of operation of Turkey Brook Park shall be extended from sunset to 11:45 p.m. from Wednesday, July 9th through Sunday, July 13th.
2. The Noise Ordinance which is applicable under normal circumstances shall be waived from a 10 p.m. deadline to an 11:45 p.m. deadline on Wednesday, July 9th through Sunday, July 13th as the carnival continues until each evening until 11 p.m. Noise may continue until 2 am on July 13th as the Carnival breaks down.
3. Certain parking restrictions are necessary and appropriate under the circumstances and those restrictions are as follows:
 - a. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department on local streets for the duration of this event, i.e. from 5 pm to 11 p.m. on July 9 through the 11 , and from 2 p.m. to 11 p.m. on July 12 and July 13.
 - b. There shall be no parking on Sunset Drive from 5 p.m. to 11 p.m. on July 9 through the 11th and from 2 p.m. to 11 p.m. on July 12 and July 13.
 - c. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department in Gold Mine Estates, from 5 p.m. to 11 p.m. on July 9 through the 11th and from 2 p.m. to 11 p.m. on July 12 and July 13.
 - d. Wynnewood Avenue between Clinton Avenue and Flanders Road, and, Chelsea Avenue between Clinton Avenue and Flanders Road shall be closed to vehicular traffic on July 12 or on the rain date of July 13, between 4 p.m. and 11:00 p.m. either day.
 - e. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department, on Pershing Avenue, Washington Street, Delbar Drive, Summit Avenue, Stanley Place, and Carson Road from 5 p.m. to 11 p.m. on July 9 through the 11th and from 2 p.m. to 11 p.m. on July 12 and July 13

4. The Carnival company shall be allowed to park their RV's within Turkey Brook Park for the purpose of providing overnight sleeping accommodations for the Carnival staff;
5. A temporary waiver to Section 176-8 of the Township Code which prohibits the posting, exhibiting and displaying of signs on Township property.
