

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE  
AUTHORIZING THE AWARD OF THE CONTRACT FOR SPORTS FIELD LIGHTING FOR  
SOCCER FIELD NO. 4 AND OVERFLOW LIGHTING FOR SOCCER FIELD NO. 3 AND  
SPECIAL EVENTS AREA AT TURKEY BROOK PARK WITH MUSCO SPORTS LIGHTING  
LLC**

WHEREAS, the Township advertised and received one bid for the provision of sports field lighting for soccer field no. 4 and overflow lighting for soccer field no. 3 and special events area at Turkey Brook Park from the following vendor,

WHEREAS, the Township Council is satisfied with the proposal submitted by Musco Sports Lighting LLC, the lowest responsible bidder, as being the proposal which satisfies the best interest of the Township and being in conformance with the requirements promulgated pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, the Township wishes to proceed with this necessary service and for that purpose accepts the proposal submitted by Musco Sports Lighting LLC.

**NOW THEREFORE BE IT RESOLVED** by the Township of Mount Olive, in the County of Morris and State of New Jersey, as follows:

1. It does hereby authorize the issuance of a contract to Musco Sports Lighting LLC for the provision of sports field lighting for soccer field no. 4 and overflow lighting for soccer field no. 3 and special events area at Turkey Brook Park, which Contract shall specify the scope of services as set forth in Musco Sports Lighting LLC's proposal, at a total cost not to exceed the amounts set forth in the proposal.
2. The Mayor is specifically authorized to execute the aforementioned contract.
