
As you may recall, Brach Eichler L.L.C. represents Carl J. Soranno and Elizabeth Soranno (the "Sorannos") with the regard to the above matter. By way of background, on August 30, 2012, the Sorannos filed a formal objection to the Highlands Applicability Determination Application filed on July 17, 2012 by their adjacent property owners, Mazouz and Tomasa Jallad ("the Jallads") regarding the property located at Lot 66, Block 7100 on Tax Map of the Township of Mount Olive, Morris County, more commonly known as 134 Flanders Drakestown Road, seeking an exemption pursuant to N.J.S.A. 13:20-1 et. seq., specifically Exemption No. 4.
