**AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF
MOUNT OLIVE AMENDING ORDINANCE #27-2009 WHICH ESTABLISHED
SALARIES FOR THE MAYOR, COUNCIL, DEPARTMENT HEADS,
SUPERVISORY PERSONNEL AND EMPLOYEES OF THE TOWNSHIP'S
CLERKS OFFICE FOR THE YEAR 2009 AND 2010**

WHEREAS, Ordinance #27-2009 provided for a salary increase for the Chief of Police for 2010 in the amount of \$134,075.79; and

WHEREAS, the correct salary for the Chief of Police for 2010 should be \$138,707.80 which includes the roll-in of a superior officer stipend and the annual uniform clothing allowance; and

WHEREAS, these roll-ins were part of the negotiated settlements for the FOP/SOP for the contract period of 2009 to 2012; and

WHEREAS, in addition the recently negotiated settlements with the FOP/SOP and MOTPEA called for one-time cash payments of \$500 which shall not be added to base salary; and

WHEREAS, Ordinance #27-009 is also being amended to provide the following exempt employees with the same one-time \$500 cash payment to be made no later than April 1, 2010:

- Chief of Police
- Director of Finance/Chief Financial Officer
- Tax Assessor
- Deputy Township Clerk
- Township Clerk
- Assistant to the Township Clerk
- Tax Collector
- Court Administrator

- Fire Inspector
- Construction Code Official
- Plumbing Inspector
- Chief Sanitarian
- Senior Citizen Director
- Recreation Supervisor
- Supervisor of Parks, Buildings and Grounds

- Benefits Coordinator
- Grant Coordinator

NOW, THEREFORE BE IT O-RDAINED by the Township Council of the Township of Mount Olive, County of Morris, as follows:

1. The above salary amendment for the Chief of Police shall be retroactive to January 1, 2010.
2. This ordinance shall take effect in accordance with law.
