

RESOLUTION _____-2016

A RESOLUTION OF THE TOWNSHIP OF MOUNT OLIVE, IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY, REJECTING THE PROPOSAL FROM MCCAFFERTY ENTERPRISES CO. INC. FOR CARNIVAL SERVICES

WHEREAS, the Township advertised and received one bid for the provision of carnival services from the following vendor as follows,

McCafferty Enterprises Co. Inc.

WHEREAS, the proposal submitted by McCafferty Enterprises Co. Inc. must be rejected as it failed to include a completed Non-Collusion Affidavit form, a mandatory item for which failure to submit is a material, non-waivable and fatal defect that renders the proposal unresponsive; and

WHEREAS, the proposal submitted by McCafferty Enterprises Co. Inc. must be rejected as it failed to include a fully completed Acknowledgment of Receipt of Changes form, a mandatory item for which failure to submit is a material, non-waivable and fatal defect that renders the proposal unresponsive pursuant to N.J.S.A. 40A:11-23.1(a); and

WHEREAS, the proposal submitted by McCafferty Enterprises Co. Inc. must be rejected as it failed to include a fully completed Proposal Form, a mandatory item for which failure to submit is a material, non-waivable and fatal defect that renders the proposal unresponsive; and

WHEREAS, the proposal submitted by McCafferty Enterprises Co. Inc. must be rejected as it failed to answer “yes” to all compliance questions on the Technical Specifications form, a material, non-waivable and fatal defect that renders the proposal unresponsive; and

WHEREAS, the proposal submitted by McCafferty Enterprises Co. Inc. must be rejected as it failed to include a fully completed Administrative Documents form, a mandatory item for which failure to submit is a material, non-waivable and fatal defect that renders the proposal unresponsive.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Mount Olive, in the County of Morris and State of New Jersey, as follows:

1. The bid proposal received by the Township for the provision of carnival services is hereby rejected in accordance with the Local Public Contracts Law and the reasons set forth in this Resolution.

2. The Township Clerk is hereby authorized and directed on behalf of the Township to re-advertise for proposal submissions for the above referenced project in accordance with the Local Public Contracts Law.

This resolution will take effect immediately upon its passage.
