NOW THEREFORE BE IT RESOLVED by the Township of Mount Olive, in the County of Morris and State of New Jersey, as follows:

1. It does hereby authorize the issuance of a contract to Peterson & Sons Tree Service, Inc., 24 Kelly Place, Stanhope, New Jersey 07874 for tree removal, trimming and stump grinding services, which Contract shall specify the scope of services as set forth in Peterson & Sons Tree Service, Inc.'s proposal, at a total cost not to exceed the aforementioned rates, as set forth in the proposal.
2. The Mayor is specifically authorized to execute the aforementioned contract.

This resolution will take effect immediately upon its passage.
