

We need your help to ask the Assembly to vote on the open space funding implementation bill A780. If adopted, this critically needed bill would implement the funding that voters approved in 2014 for Green Acres, farmland and historic preservation programs. The Senate already passed the same bill by a large, bipartisan majority.
