

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF
MOUNT OLIVE SUPPORTING AN APPLICATION TO THE NEW JERSEY
DEPARTMENT OF TRANSPORTATION FOR THE ADOPTION OF FOUR (4)
PERMANENT NJ TRANSIT BUS STOPS ALONG US ROUTE 46 WITH IN THE
TOWNSHIP OF MOUNT OLIVE**

WHEREAS, the Mount Olive Township Police Department Traffic Division has received a letter from the NJ Department of Transportation asking for a review of all NJ Transit Bus stops along US Route 46 within the Township; and

WHEREAS, the Mount Olive Township Police Department Traffic Division has conducted that review; and

WHEREAS, the Mount Olive Township Police Department Traffic Division has determined that there is a need to establish four (4) permanent NJ Transit Bus Stop locations along the US Route 46 corridor within the Township; and

WHEREAS, those locations are as follows:

- 1) Along Rt. 46 eastbound on the southerly side at Johnson Ave (near side), beginning at the westerly curb line of Johnson Ave and extending 105 feet westerly therefrom.
- 2) Along Rt. 46, eastbound, on the southerly side of Old Budd lake Road (near side), beginning at the westerly curb line of Old Budd lake Road and extending 105 feet westerly therefrom.
- 3) Along Rt. 46 westbound, on the northerly side at the Village Green Shopping center, beginning at the westerly curb line of the middle shopping center entrance/exit extending 205 feet westerly therefrom.
- 4) Along Rt. 46 westbound, on the northerly side at Sand Shore Road (CR#649) (near side), beginning at the westerly curb line of Sand Shore Road and extending 105 feet westerly therefrom; and

WHEREAS, Mount Olive Township Police Department Traffic Division is in agreement that all other NJ Transit Bus Stops be eliminated along the US Rt. 46 corridor within the Township as being either inactive or located in unsafe locations; and

WHEREAS, the Township feels it is in the best interest of the health, safety and welfare of the Township and its residents to have the State DOT establish these four (4) permanent NJ Transit Bus stop locations and eliminate all other NJ Transit Bus stop locations along the US Rt. 46 corridor within the Township as being either inactive or located in unsafe locations; and

WHEREAS, the Township of Mount Olive has determined that adoption of this Resolution in support of an application to the New Jersey Department of Transportation for the

adoption of this Resolution in support of an application to the New Jersey Department of Transportation for the establishment of these four (4) permanent NJ Transit Bus stop locations and elimination of all other NJ Transit Bus stop locations along the US Rt. 46 corridor within the Township as being either inactive or located in unsafe locations is in the best interest of the health, safety and welfare of the Township and its residents.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Mount Olive that it hereby endorses the submission of the application to the New Jersey Department of Transportation for this adoption as requested.

BE IT FURTHER RESOLVED, that the Mt. Olive Police Department is hereby requested to submit in writing the necessary paperwork to the NJ DOT to establish these four (4) permanent NJ Transit Bus stop locations and eliminate all other NJ Transit Bus stop locations along the US Rt. 46 corridor within the Township as being either inactive or located in unsafe locations
