

Kennedy Smith helps communities create innovative economic development strategies for downtowns and commercial corridors. As a partner in the CLUE Group for the past ten years, and as a senior staff member of the National Main Street Center for 19 years before that (including serving as the Center's director from 1990-2004), she has worked with hundreds of communities of all sizes throughout the US and abroad. Some of her recent assignments include outlining strategies for developing independently owned businesses in Washington, DC; shaping economic development strategies for downtown master plans in Lubbock, Muncie, and High Point; and identifying new sources of capital for rehabilitating 200 Romanian churches. In addition to her work with the CLUE Group, she teaches a graduate-level class in historic preservation economics for Goucher College. "Fast Company" magazine included her in its first list of "Fast 50 Champions of Innovation", and Planetizen.com included her in its international list of "Top 100 Urban Thinkers of All Time". She was a Loeb Fellow at the Harvard University Graduate School of Design in 2005-2006.
