

New Report: Statewide Change, One Community at a Time

This week, Sustainable Jersey released the Statewide Sustainability Report examining the emerging phenomenon of state-local sustainability programs in the United States. This study identifies twelve statewide programs across the U.S. that recognize local governments for achieving voluntary sustainability standards. Sustainable Jersey is a leader among this group, with the largest number of participants and fastest growth rate.



Funded by the Surdna Foundation, this study was guided by a working group comprised of representatives of five state-local sustainability programs including: Minnesota GreenStep Cities, Sustainable Maryland, Sustainable Pennsylvania, Wisconsin Green Tier Legacy Communities and Sustainable Jersey. Key personnel from Green Cities California, Clean Energy Communities (CT), the Florida Green Building Coalition, Massachusetts Green Communities, Michigan Green Communities, Climate Smart Communities (NY) and Go Green Virginia also contributed to the report. These groups have now come together and are forming a national network to share resources and best practices and to enhance our collective positive impact.

Funding & Technical Assistance Opportunities

2016 Safe Routes to School Program (SRTS) Grants

The SRTS grant program is funded through the Federal Highway Administration's Federal Aid Program and is being administered by the NJDOT, in partnership with the North Jersey Transportation Planning Authority (NJTPA), the Delaware Valley Regional Planning Commission (DVRPC), and the South Jersey Transportation Planning Organization (SJTPO). Proposed projects must be located within two miles of a school that serves students in grades K-8. Funding for the 2016 SRTS Program will be available for the construction of infrastructure projects only, such as the installation of sidewalks, crosswalks, bike lanes, multi-use paths, traffic calming measures, and other means to ensure the ease and safety of children walking or biking to school. For this solicitation, Urban Aid Communities determined by the Department of Community Affairs, and municipalities containing Schools Development Authority (SDA) Districts outlined by the Educational Facilities Construction and Financing Act, may apply for design as well as construction funds. Any municipality, school district, or county is eligible to apply for funding. Non-profit organizations are not eligible as direct grant recipients for this solicitation. However, non-profit organizations may partner with a local public agency that will assume responsibility and administration for the grant. For more information visit their [website](#).

The New England Interstate Water Pollution Control Commission (NEIWPCC), in cooperation with the Environmental Protection Agency (EPA) and state partners, is inviting proposals for projects to be funded under the New York / New Jersey Aquatic Trash Prevention Grant Program. EPA is providing these financial resources for projects aligned with the goal of EPA's Trash Free Waters program, for watersheds in both New York and New Jersey. 
Green Communities Grant Application


