AN ORDINANCE OF THE TOWNSHIP OF WASHINGTON, COUNTY OF MORRIS, AND STATE OF NEW JERSEY TO AMEND CHAPTER 217, ZONING, OF THE CODE OF THE TOWNSHIP OF WASHINGTON REGARDING SECTION 217-38 RIDGELINE, MOUNTAINSIDE, HILLSIDE AND VIEWSHED PROTECTION AREAS REQUIREMENTS

WHEREAS, the Township Committee wishes to establish standards for the Township Engineer or Planner to review and approve an accessory structure that is 500 square feet or less in area and 16' or less in height on an existing lot of record within the Ridgeline, Mountainside, Hillside and Viewshed Protection Area, under certain circumstances, in lieu of the existing ordinance requirement for a property owner to make application to, and secure approval of a Ridgeline, Mountainside, Hillside and Viewshed Certificate of Compliance from the Planning Board or Zoning Board of Adjustment.

NOW, THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Washington, in the County of Morris, and State of New Jersey, as follows:

SECTION 1. Chapter 217, Zoning, Article V. Supplementary Lot, Height and Yard Regulations, Section 217-38, Steep slopes, ridgeline, mountainside, hillside and viewshed protection areas, Subsection F, Ridgeline, mountainside, hillside and viewshed protection areas requirements, paragraph (3), Requests for zoning permits and/or building permits, item c., of the Code of the Township of Washington, Morris County, New Jersey, is hereby amended and supplemented to read as follows:

"c. No such certificate of compliance shall be required for an addition to an existing dwelling located within the ridgeline, mountainside, hillside and viewshed protection areas except when such addition shall increase the habitable floor area of a dwelling by more than 25%. Incremental additions occurring after the date of adoption of this section which result in a cumulative increase in habitable floor area of 25% beyond the habitable floor area of the dwelling as of the date of the adoption of this section, shall be permitted only when such certificate of compliance has been received. Construction of new accessory structures such as detached garages on existing developed lots of record within the ridgeline, mountainside, hillside and viewshed protection areas shall require the issuance of such a certificate of compliance prior to the issuance of a Building Permit, provided, however, that no certificate of compliance shall be required for a building permit for an accessory structure on an existing lot of record when:

- 1) the accessory structure is 500 square feet or less in area; and
- 2) the accessory structure is 16' or less in height; and
- 3) the Township Engineer or Planner determines that the objectives of §217-38.F. are met or are not applicable to the proposed accessory structure development; and
- 4) the review fee as required by §217-38.F(10) has been paid."

SECTION 2. The Township Clerk is hereby directed to give notice at least ten days prior to hearing on the adoption of this Ordinance to the County Planning Board and to all other persons entitled thereto pursuant to N.J.S. 40:55D-15 and N.J.S. 40:55D-63 (if required). Upon the adoption of this Ordinance after public hearing thereon, the Township Clerk is further directed to publish notice of the passage thereof and to file a copy of the Ordinance as finally adopted with the Morris County Planning Board as required by N.J.S. 40:55D-16. The Clerk shall also forthwith transmit a copy of this Ordinance after final passage to the Township Tax Assessor as required by N.J.S. 40:49-2.1.

SECTION 3. This Ordinance may be renumbered for codification purposes.

SECTION 4. All ordinances of the Township of Washington, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.



SECTION 6. This Ordinance shall take effect immediately upon final passage, approval, and publication as required by law.


