

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT
OLIVE RELATIVE TO MOUNT OLIVE WEEK CARNIVAL
JULY 6TH THROUGH JULY 10TH**

WHEREAS, the Township's Recreation Department is planning what is to be known as the Mount Olive Week Carnival which will be conducted from July 6th to July 10th with fireworks scheduled for July 9th at approximately 9:15 p.m.; with a rain date of July 10th; and

WHEREAS, it is necessary to make some restrictions as to parking during these events and to waive certain other restrictions for the operations of the carnival; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Mount Olive as follows:

1. The hours of operation of Turkey Brook Park shall be extended from sunset to 12:30 a.m. from Wednesday, July 6th through Sunday July 10th. The extension of park hours is required for the carnival and necessary nightly clean-up. The hours of the carnival are:

- Wednesday July 6th from 6:00 PM to 11:00 PM
- Thursday July 7th from 6:00 PM to 11:00 PM
- Friday July 8th from 6:00 PM to 12:00 AM (Midnight)
- Saturday July 9th from 3:00 PM to 12:00 AM (Midnight)
- Sunday July 10th from 3:00 PM to 8:00 PM
- Fireworks are planned for Saturday July 9th at approximately 9:15 PM, in the event of rain for the fireworks, the Sunday carnival hours will be 3:00 PM to 10:00 PM.

2. The Noise Ordinance which is applicable under normal circumstances shall be waived from a 10:00 PM to 12:00 AM (midnight) on Wednesday, July 6th and Thursday July 7th, and for Friday and Saturday rides ending at midnight, and clean until 12:45 AM. Sunday, July 10th, rides end at 8pm, unless it is the rain date for the fireworks, then Saturday hours are in effect. Noise may continue until 12:00 AM on July 10 as the Carnival breaks down.

3. Certain parking restrictions are necessary and appropriate under the circumstances and those restrictions will be in effect from Wednesday July 6th to Sunday July 10th:

a. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department on local streets for the duration of this event.

b. There shall be no parking on:

- Carson Road

- Chelsea Avenue between Clinton Avenue and Flanders Road
