

**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF
MOUNT OLIVE AWARDING A PROFESSIONAL SERVICE
AGREEMENTS UNDER THE NON-FAIR AND OPEN CONTRACTS IN
ACCORDANCE WITH THE PAY-TO-PLAY LAW IN CONNECTION WITH THE
COBBLESTONE HEALTH CARE FACILITY, 20-23 STONEWALD COURT DRIVE,
BUDD LAKE, NEW JERSEY, BLOCK 3203 LOTS 21 & 28
(Integra Realty Resources)**

WHEREAS, the Township of Mount Olive has a need to acquire professional services as a “non-fair and open” contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate; and

WHEREAS, the Township wishes to retain the services of Integra Realty Resources to prepare a real estate appraisal report and for such other services as identified in its proposal dated May 14, 2015; and

WHEREAS, Integra Realty Resources has completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in Mount Olive in the previous one year, and that the contract will prohibit them from making any reportable contributions through the term of the contract.

WHEREAS, N.J.S.A. 40A:11-5 (a)(i) states that, if a municipality utilizes the professional services exemption from the Local Public Contracts Law, “The governing body shall in each instance state supporting reasons for its action in the resolution awarding each contract and shall forthwith cause to be printed once, in the official newspaper, a brief notice stating the nature, duration and service and amount of contract, and that the resolution and contract are on file and available for public inspection the office of the Township Clerk.

NOW THEREFORE BE IT RESOLVED that the Township Council of the Township of Mount Olive authorizes the Mayor to execute one year contract with Integra Realty Resources in the amount of \$4,500 in connection with Cobblestone Health Care Facility, 20-23 Stone Wald Court Drive, Budd Lake, New Jersey, Block 3203 Lots 21 & 28 subject to the Chief Financial Officer certification of funds.

BE IT FURTHER RESOLVED that the Business Disclosure Entity Certification and the Determination of Value to be placed on file with this resolution; and

BE IT FURTHER RESOLVED that this resolution will be published in the Township’s legal newspaper.
