

Best Friend The Steven & Beverly Rubenstein Foundation

Several years ago, Sal Iannacone, our 2013 Distinguished Service Award winner, was about

to begin overseeing the development of a new respite group home in Hanover Township. Realizing we were short of funding, he invited Andrew Rubenstein and Barry Mandelbaum from the Steven & Beverly Rubenstein Charitable Foundation to visit one of our group homes to discuss the project.

They met Executive Director Bill Testa that morning, toured the facility, and before the end of the visit, made a pledge for a substantial amount of funding for what became the Rubenstein Respite Group Home.

For their incredible support in creating a facility that has truly filled a huge service gap, the Steven & Beverly Rubenstein Charitable Foundation received the 2016 Best Friend Award.

Bill Sackter Award Bianca Galasso

The Bill Sackter Award is given each year to recognize an individual with intellectual disabilities who is an achieving, integrated member of his or her community. This year's winner is Bianca Galasso.

When Bianca was five years old, she moved into the Vineland State School. It was March 6, 1939—two years before we entered the Second World War. 41 years later, in 1980, Bianca moved to the North Jersey Training School in Totowa. It was from there, in 1984, that she returned to the community to live in our third group home in Hanover Township.

Bianca has experienced much over the last 32 years—and we have many wonderful stories. A favorite story involves the development of the Washington Township Group Home, just a year or two after Bianca moved to Hanover. Bianca and her housemates hosted a get together for ladies from North Jersey who were learning about what group homes were all about.

They were scared and uncertain about moving to the community. Bianca knew some of the ladies from her Totowa days, including Margie DeCamp.

Bianca and the other residents of Hanover were great sales people. They put the future residents at ease, and a wonderful and successful transition took place. Ironically, Bianca ended up moving to the Washington home in 2005, where Margie continues to live. They remain housemates today, Bianca a young 82 and Margie an amazing 95 years young!

For exemplifying the fortitude and spirit behind the award, we were honored to present Bianca with the 2016 Bill Sackter recognition.

Distinguished Service Award Peter J. Murphy

In his 25th year of service to The Arc/Morris Chapter, Peter Murphy was presented the 2016 Distinguished Service Award.

One of the most unheralded employees in the organization, Peter brought well over 15 years' experience to The Arc/Morris Chapter when he was hired in 1992. He immediately displayed both an intellect and a work ethic second to none.

Inheriting a budget that actually operated in a deficit the year before, Peter went to work in areas not completely within his experience. His incredible intelligence and will to learn anything necessary proved invaluable to setting the agency on a strong course to improve the administration and business operations.

Over the years, his work has been as diverse as the agency itself. Whether working in partnership with the public sectors through the state Division of Developmental Disabilities and the US Department of Housing & Urban Development, or in our own capital campaign nearly ten years ago—his mark on the agency is indelible.

Peter's genuine commitment to the people we serve has also been exemplified repeatedly. Advocating for improved management of consumer funds, he stepped up as we joined a DDD Representative Payee Pilot project over 15 years ago. Not knowing how critical this would be years later, Peter designed and implemented an accounting system that maximizes resources to the consumer, while assuring the maintenance of entitlements. This work was way ahead of its time and will prove invaluable as we move closer to the radical changes currently underway.

Peter Murphy has truly exemplified all of what is embodied by our Distinguished Service Award.

FROM THE EXECUTIVE DIRECTOR



Shortly after this year's Annual Awards & Volunteer Recognition Program, long-time volunteer, benefactor and board member Herman Rosenberg celebrated his 100th birthday. Acknowledging this milestone so soon after our recognition event served as another reminder of how one life can have such an incredible impact on so many.

Rosie was surrounded by family and friends on June 12 to celebrate a century of life. Growing up in Morristown, attending Drew University and serving in World War II only took up a quarter of what has been a truly remarkable run for this incredible man. As a member of the greatest generation, he, and so many others, lived through the Great Depression, fought to defend our country and returned home to pave the way to an era of prosperity unparalleled in modern history.

Connecting with our organization soon after the birth of their son, Mark, and daughter Gina, who was born with special needs, he and his beloved wife Jessie became an intricate part of our organization soon after its formation in the 1950's. And through this remarkable family, so much change came about. In many ways, they refused to allow the American dream to allude them—or their daughter. Choosing to keep Gina at home, like others, they were faced with misunderstanding, stigma and a world ill prepared for people with disabilities.

After the early organizing years, the fight for public education and community programs began. When Gina completed her school years and was faced with a life devoid of any meaning, they stepped forward and what emerged was the day habilitation service that, to this day, provides meaningful activities for individuals with significant intellectual and other developmental disabilities.

Years later, faced with a crisis that nearly caused the demise of the Chapter, it was Rosie, Jessie, and many of their closest family and friends, that stood by the organization to make sure it survived.

And survive it did. As the modern era in our field began in the early 1980's, Rosie continued to be a workhorse behind the growth and development so evidenced in that decade. Whether bringing energetic and committed volunteers into the agency, mobilizing civic and social organizations, or rolling up his sleeves at board meetings, Herman Rosenberg continued to be a backbone of The Arc/Morris.

To this day, Rosie remains a trusted confidant, well aware of where we have come from—and as equally committed to where we are going as he was over sixty years ago. In his own words, "Keep going, don't stop", says it all.

But Donna has also taught her swimmers more than just how to win. Over ten percent of her 120 swimmers have special needs—and fully participate in all of the team practices and meets. And if they are unable to get in a particular meet, Coach Donna makes sure there is an additional event to give them that opportunity.

Instilling this sense of service in her swimmers has resulted in some remarkable young people. According to one of her athletes, 'seeing the special needs kids overcome great obstacles makes all of us better swimmers'.

13th Annual Walk Planned for September


