Licensed Electrician Services, which Contract shall specify the scope of services as set forth in Accuracy Electric Inc.'s proposal, at a total cost not to exceed the aforementioned rates, as set forth in the proposal.
2. The Mayor is specifically authorized to execute the aforementioned contract.
