

RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MOUNT OLIVE RELATIVE TO MOUNT OLIVE WEEK CARNIVAL (7/8/15-7/12/15) AND FIREWORKS SCHEDULED FOR (7/11/15) AND RAIN DATE (7/12/15)

WHEREAS, the Township's Recreation Department is planning what is to be known as the Mount Olive Week Carnival which will be conducted between July 8th and July 12th with fireworks scheduled for July 11th with a rain date of July 12th for 9:15pm; and

WHEREAS, it is necessary to make some significant restrictions as to parking during these events and to waive certain other restrictions so that the programs may go forward.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Mount Olive as follows:

1. The hours of operation of Turkey Brook Park shall be extended from sunset to 11:45 p.m. on Wednesday, July 8th and Thursday July 9th, and until 12:45a.m. Friday, July 10th through Sunday, July 12th.
2. The Noise Ordinance which is applicable under normal circumstances shall be waived from a 10 p.m. deadline to an 11:45 p.m. deadline on Wednesday, July 8th and Thursday July 9th, and until 12:45a.m. Friday, July 10th through Saturday, July 11th. Noise may continue until 2:45 am on July 12th as the Carnival breaks down.
3. Certain parking restrictions are necessary and appropriate under the circumstances and those restrictions are as follows:
 - a. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department on local streets for the duration of this event, i.e. from 5 pm to 11:30 p.m. on July 8 and July 9, from 5pm to 12:30a.m. on July 10 and from 2 p.m. to 12:30 a.m. on July 11 and July 12.
 - b. There shall be no parking on Sunset Drive from 5 pm to 11:30 p.m. on July 8 and July 9, from 5pm to 12:30a.m. on July 10 and from 2 p.m. to 12:30 a.m. on July 11 and July 12.
 - c. Parking shall be restricted, limited, or prohibited, as directed or posted by the police department in Gold Mine Estates, from 5 pm to 11:30 p.m. on July 8 and July 9, from 5pm to 12:30a.m. on July 10 and from 2 p.m. to 12:30 a.m. on July 11 and July 12.
 - d. Wynnewood Avenue between Clinton Avenue and Flanders Road, and, Chelsea Avenue between Clinton Avenue and Flanders Road shall be closed

to vehicular traffic on July 11 or on the rain date of July 12, between 4 p.m. and 12:30 a.m. either day.

Parking shall be restricted, limited, or prohibited, as directed or posted by the police department, on Pershing Avenue, Washington Street, Delbar Drive, Summit Avenue, Stanley Place, and Carson Road from 5 pm to 11:30 p.m. on July 8 and July 9, from 5pm to 12:30a.m. on July 10 and from 2 p.m. to 12:30 a.m. on July 11 and July 12.

4. The Carnival company shall be allowed to park their RV Brook
Park for the purpose of providing overnight sleeping accommodations for the
Carnival staff;
5. A temporary waiver to Section 176-8 of the Township Code which prohibits the
posting, exhibiting and displaying of signs on Township property.
