Notice is hereby given by the Township of Mount Olive that sealed bids will be received by the Township Administrator on **Wednesday, July 23, 2014 at 10:00AM** prevailing time in the Municipal Building, 204 Flanders-Drakestown Road, Budd Lake, NJ 07828 at which time and place the sealed bids will be open publicly and read for the following:

### **BID# 17-2014 Improvements to International Drive South – Phase I**

**Scope of Project:** This project entails the milling, resurfacing, select base repairs and restriping of International Drive South for a length of approximately 2,900 linear feet. Additional work shall include the removal and replacement of concrete curb and sidewalk, the resetting of manholes and drainage structures.

**Project Completion:** The Bidder agrees to complete the entire work for this contract within sixty (60) calendar days from the date specified in the Notice to Proceed.

**Examination of Contract Documents:** Contract documents may be examined Monday through Friday, except legal holidays, from 9:00AM to 4:00PM only at the office of the Engineer.

**Obtaining Bid Document:** Contract documents may be obtained ONLY from the office of the Engineer at the address and hours set forth above upon payment of seventy-five dollars (\$75.00) for each set of contract documents. All refunds shall be forwarded in strict compliance with NJSA 40A:11-24(b).

**Bid Security:** Bid Security is required in amount of not less than ten percent (10%) of the total amount of the Bid, but not in excess of twenty thousand dollars (\$20,000) as set forth in NJSA 40A:11-21.

**Submission of Bid:** Bids must be submitted on the Bid Form contained in the contract documents and must be enclosed in a sealed envelope plainly marked on the outside with the name of project and the name and address of the bidder. The Bid MUST be delivered to the owner prior to Bid opening at the above address for submitting bids.

**Consent of Surety:** Certification from a Surety Company is required indicating consent to be bound as surety and guarantor for performance under the Contract Documents.

**Contractor Registration:** Bidders are required to be registered by the New Jersey Department of Labor at the time bids will be received by the Project Owner pursuant to the Public Works Contractor Registration Act (P.L. 2003, c. 91, N.J.S.A. 34:11-56.51). Effective September 1, 2004, Bidders are also required to be registered by the New Jersey Department of Treasury, Division of Revenue at the time bids will be received by the Project owner pursuant to the Business Registration Act (P.L.2004, c.57, N.J.S.A.52:32-44).

## *Legal Notice to Bidders*

**Statutory Requirements:** Bidders are required to comply with applicable statutory requirements set forth in the Contract Documents including the requirements of N.J.S.A. 10:5-31, et seq. & N.J.A.C. 17:27-1.1, et seq. (Affirmative Action); P.L. 1963, c. 150 (Prevailing Wage); Americans with Disabilities Act of 1990 (42 U.S.C. 12101, et seq.); and P.L.2004, c.19 & P.L.2005, c.271 (Pay to Play). In addition, effective August 1, 2005, PL 2005, c.67 authorized a new form of change order called "Value Engineering Construction Change Orders". Please review these specifications to determine if this bid will involve this new form of change order for contracts that are estimated to exceed \$5,000,000.

**Rejection of Bids:** The Township of Mount Olive reserves the right to reject any or all bids, or to waive any Bid defect where such defect is not detrimental to the best interest of the Township and fairness of the bidding process. The right is also reserved to increase or decrease the quantities specified in the manner designated in the contract documents.
