I just wanted to at least highlight that, bring it out.

ADMINISTRATIVE REPORTS

President Nicastro: Administrative Reports. Mayor, Laura?

Mayor Greenbaum: Monster Mash Dash and Glow Run is still accepting registrations. We have more registrations now than we did last year, so good for Recreation. Sweet Pea Flower Shop will be officially opening on Saturday. They're located on Route 46, next to the barber shop, 117 Route 46, Budd Lake. Pastoral Pig will be hosting their official grand opening on Friday, October 21, 2016 at 6:00 pm. We will be recognized at the League of Municipalities as being a Bronze Certified Township under Sustainable Jersey. In addition, we're still working on our Silver Certification. November 2, 2016 at 6:30 pm at the Regency in Flanders, there will be a wine tasting event for the Lyons Club. If anyone's interested in going you can see me to get tickets. Do you have anything?

President Nicastro: Anything?

Miss Harris: A couple of things. First off, 8 Main Street was sold at auction last week for \$17,500.00. The details of who purchased it and what it's going to be used for is in the monthly report that I sent, I think it was last Friday. Also, I think you noticed we met with the residents of Sunset Drive, just to reassure them that everything's on track. We just had a little communication gap so we're going to give them a monthly update each month, just to...just in case things don't happen as planned the way they did this time around. Everything is okay there. There was one thing I wanted to run by you all, I was hoping to be able to replace the snowflakes that we put up every year with something non-electric. We've been having a lot of problems with them. The boxes that they're mounted on were made by a JCP&L employee who's since retired, so they're obsolete. Like I said, I want to do something non-electric so it's more environmentally friendly and requires less maintenance, less time. We were thinking about something like tinsel candy canes that have kind of glittery...that light would reflect off of them. Maybe some wreathes, possibly putting them up on more poles throughout Town because we wouldn't be limited to the poles that just have the boxes on them. They're about \$200.00 a piece according

to the catalog, we might get them for less money. I just wanted to check with you all and see if it was something that you'd be okay with before I pursued it?

President Nicastro: Mr. Roman.

Mr. Roman: I for one like them being lit at night, I think it's a beautiful visual. What...how much is it currently costing us if we were to...I'm assuming the boxes need to be replaced with other lit ones?

Miss Harris: Well we can't...the boxes are not replaceable.

Mr. Roman: Okay.

Miss Harris: I was kind of trying to be a little proactive before we started losing all of them and get something that wouldn't require any maintenance or any concern that it would eventually become obsolete. I kind of like the idea of the...you know...the candy canes and the wreaths which would be non-denominational and I think because of where they're placed on light poles you would still get a reflection off them. They would not have the same glow obviously than an electric ornament would, but I just thought it would be a lot less maintenance and a lot less time consuming and possibly more long-lasting.

Mr. Roman: I for one would like to at least have a quantitative number of like what...what is our current maintenance cost...you know...if it's something...if you're telling me it costs \$100,000.00, okay then obviously I would have second thoughts, but if it's costing...I don't know...\$10,000.00, let's just throw a number out there, to purchase replacement ones that lit up, I'd be more incline going through the...you know...the ones that light up at night.

Miss Harris: Yes, it's hard to say because it's more a matter of staff time then actual...you know...hiring people to do it.

Mr. Roman: If we had numbers on that I think it would be extremely helpful.

Mr. Stewart: At least an estimate.

Miss Harris: Okay.

Mr. Ferrante: Our staff installs the lights, right?

Miss Harris: No, we actually hire somebody to install the lights. It's more of time spent on going out and looking at the ones that are supposedly out, contacting JCP&L...you know...it's...believe it or not every single day during the Holiday Season we have to deal with one light bulb or another or several.

President Nicastro: How many do we have of those, Laura?

Miss Harris: I think we have about 15 now. What I wanted to do is expand over...possibly around Turkey Brook Park...you know...some of the other parks, maybe on...in front of the Shoprite and on Route 206 and other areas where people actually do go to shop. It was just a thought. I wanted to run it by you.

Mr. Stewart: It's a good thought, but...

President Nicastro: Mr. Amianda.

Mr. Amianda: Do we have money in the budget Laura?

Miss Harris: That's why I'm asking. We would put it in the budget if...if it's something that Council wanted to pursue.

President Nicastro: Mr. Mania.

Mr. Mania: Thank you Mr. President, may the Lord be with you.

President Nicastro: Sorry...we didn't know if you were on the Christmas...

Mr. Stewart: We weren't sure if you...if it was you or your alto ego.

Mr. Mania: You thought it was Mrs. Labow again. Question for the Administration and correct me if I'm wrong. Did we not have a bid out for a generator?

Miss Harris: We have a grant for a generator and we're currently in the process of re-bidding it for...I think or getting the paperwork to bid it for the third time.

Mr. Mania: Okay.

Miss Harris: We've gotten...we've gotten plans and specifications twice from the vendor who's been doing the planning for it, but they haven't been up to legal par so we have to keep going back to them. I think we're about ready to bid it though.

Mr. Mania: Will that be a gas generator or a diesel generator?

Miss Harris: It's going to be gas.

Mr. Mania: Gas. Makes sense.

Miss Harris: Yes, the diesel generators are much more expensive.

Mr. Mania: Thank you.

President Nicastro: Thank you. Anyone else? Any other questions? I guess on the Christmas things, if you wanted to come back with some ideas and dollars on both sides then I guess we can look at that.

Miss Harris: Okay.

President Nicastro: Alright.

Miss Harris: Thank you.

President Nicastro: Anything else? Administrative, that's it? Thank you. Any Old Business from anyone? Any New Business from anyone? Any Legal Matters?

Ms. Sharpe: Yes, two items. First the New Jersey Foreign Trade Zone Venture settlement that we talked about at the last meeting, that is progressing. We've signed off as you authorized us to. However, the plaintiff's having some trouble finding actual people to sign off for some of the banks that are sort of remotely connected to it, so it's taking a little more time than anticipated, but we expect within the next 30 to 45 days that should be done. The other item, perhaps Laura might want to chime in on is we'll be participating and meeting with DEP tomorrow in Trenton regarding the solar project at the landfill. Thank you to Michelle for digging out some old documents that will be very helpful tomorrow. We're hoping for a very productive meeting to move the project forward. That's it.

Senior Citizen Liaison

Mr. Amianda: No report on Board of Education, but I have a report on Senior Citizen's. Mount Olive Senior Citizen's Association Club held a social meeting today, October 18, 2016. There were about 103 people in attendance. Among the items discussed were senior's birthdays and wedding anniversaries. They held an indoor Halloween Parade from which three best dressed in costumes were picked for prizes. The Club President informed members about the upcoming important dates including Thanksgiving Day on November 24, 2016 and Senior's Christmas Party on December 25, 20...I think I need to correct that...on December 15,
