It's actually the old building, but thanks to some creative architectural work they were able to save the building, it was a plan that took several years to actually accomplish and they were all extremely happy. It was a very nice service attended by a large contingent of their parishioners. Last evening, myself, Lisa Brett and Joe Nicastro attended the community inter-faith Thanksgiving service at St. Elizabeth and I have to tell you, it was a lovely service. They had the music presentation, I thought was phenomenal. They had not only musical instruments, but they had a chorus that consisted of younger residents within the Township, I would say that most of the kids were probably between seven and twelve and it was really, really nice. Board of Education Liaison Report

Mr. Amianda: Yes. The Board of Education met yesterday, November 23, 2015, 6:30 pm at the Middle School. The meeting was well attended by students, teachers and parents. The Board went through the Agenda, Superintendents Report, Personnel, Curriculum, Business and Policy Reports. The Board of Education held the Fall 2015 Sports Award Ceremony for Mt. Olive Department of Athletics on November 23, 2015. The Board also recognized teachers who have been members of the school district for 20 years, 25, 30, 35 and 40 years, and that's it.

President Nicaastro: Mr. Mayor.

Mayor Greenbaum: I was fortunate to happen on a meeting between Larrie Reynolds, Laura Harris and Lisa Brett that was happening last week and I am pleased to report that the School Board is looking for several shared service opportunities going forward, the first of which is the building of a community swimming pool. The Board of Education has indicated their interest in participating in the costs associated with the pool. They have indicated that they have land which could be used at Tinc Road School and that they would also be interested in funding the bubble that would go over the pool to provide for year round...their year round needs, so that aspect of the Water Recreation in Town, which was kind of discussed, but put on the back burner now has some new life in terms of we're going to look at the costs associated with the installation of a pool, the running of a pool, and have further discussions with the School Board. I expect those discussions to occur during the year 2016 and if appropriate, to be funded in 2017. That's a very positive development. The School Board is also interested in furthering their marketing aspect of the Marauder brand and they have indicated that when and if it becomes time to repaint the Clover Hill water tower, that they would be interested in participating in the cost so long as ultimately there was something that was on the tower that said "Home of the Marauders" with the pirate...

Mrs. Labow: Nice.

Mayor Greenbaum: ...which I think is great for the Township. Unfortunately right now, because of some issues related to the last time we painted that tank I'm not exactly sure when that's going to occur. There were some discussions that I had with Tim Quinn during the budget process that when the tanks were painted three to

four years ago, there was some kind of chemical that was put in to help with respect to the anti-rusting aspect that may have actually led to the paint peeling off. We're looking at whether or not that's a warranty issue or whether there was negligence in terms of the tank painting, so once that gets resolved we'll have some kind of schedule in terms of where we're going with repainting that tank. I can tell you that in this year's budget the effort in terms of repainting water tanks is focused primarily up at the garden apartments, the tower up on the hill because we're starting to have some rusting issues with those tanks. It really needs to be repainted.

President Nicastro: Good. Good news.

Mayor Greenbaum: Okay.

Mr. Mania: Just a quick comment, if I may.

President Nicastro: Yes.

Mr. Mania: Usually why paint peels is when moisture gets behind it. That's what causes paint to peel.

Mayor Greenbaum: Yes, well, you know somebody who comes in who's a specialist that I am sure that these companies that's what they do, they paint water tanks because we all know that it costs several hundreds of thousands of dollars to paint tanks, they should be aware of what is required to make sure that the tank doesn't need to be repainted in three years rather than 20 years or 15 years, so we're looking at that issue currently. As soon as I have an answer, I'll be better able to advise Council as to where we're going.

President Nicastro: Mr. Stewart.




